## THE COMPETITION IS OPEN TO

Artists who employ video in work connected to the use of traditional, electronic, and information technologies as means of artistic expression.

Works produced while enrolled in a visual arts program, including an Academy of Fine Arts, Film School, Specialized Art Institute, or University.

This exhibition is being organized to promote emerging artists who work with video. The reward offered to the 10 young artists selected include:


- Inclusion in a catalogue that documents the 10 selected works and contains a DVD with brief previews of each video;

# ELIGIBILITY FOR PARTICIPATION IN THE COMPETITION

Participation in this exhibition is open to students, video artists, and beginning directors, both Italian and foreigners located in the regions of Friuli Venezia Giulia, Veneto, Osterreich, Hrvatska, Slovenija.

The age of the participant at the time of submission must not exceed 30 years old.

Only works completed after January 1, 2007 may be submitted.

The maximum length of videos is 5 minutes. (Only in exceptional cases, at the discretion of the curator, will longer videos by selected, and in any event not longer than 10 minutes).

## REGULATIONS

FAILURE TO COMPLY WITH ONE OR MORE OF THE FOLLOWING RULES WILL RESULT IN DISOUALIFICATION OF THE CONTESTANT AND HIS/HER WORK

### Art.1

Complete all parts of the entry form, including the authorization for the Associazione Amici della Galleria Spazzapan, Associazione Culturale Lucide e Associazione Culturale Scimmie Bisiache to use the work for didactic, cultural, and promotional purposes, without monetary gain, through publication in newspapers, via the Internet, and public presentation;

## Art.2

Submit 2 copies of the work in mov or avi file in form factor miniDV or dvd (recommended) or dvd format (accepted);

### Art. 3

Submit 2 copies of the artist's curriculum vitae, in Italian or English, and in digital format;

Submit an abstract of the work in Italian or English;

## Art.5

Entrants must submit a CD-ROM with at least 2 high-resolution (300 dpi), JPEG/TIFF screen captures from the video, or other images RELEVANT TO THEIR WORK, along with their express written consent allowing partial and/or full use of the submitted work for informational purposes; (in application form)

### Art.6

Submit an itemization of the original music selected for use as a soundtrack, indicating the composers and titles. Furthermore we require written authorization from the composers for the music used in the selection (in application form).

## SELECTION COMMITTEE

The selection committee that will review the submitted work will be organized by Andrea Bruciati, Director of the Galleria d'Arte Contemporanea di Monfalcone (Gorizia).

All decisions of the selection committee are final.

Submitting work to this competition constitutes complete acceptance of the regulations and consent for photographic and audio-video reproduction of the selected works in print or digital publications.
